WHEREAS, It is incumbent upon the people of the State of New York to recognize and acknowledge those within our midst who have made significant contributions to the quality of life therein; and

WHEREAS, This Legislative Body is justly proud to commend Tischler Dental upon the occasion of its designation as recipient of the 2007 New Building Project of the Year Award by the Ulster County Chamber of Commerce and the Ulster County Development Corporation to be held on Thursday, October 11, 2007, Kingston, New York; and

WHEREAS, Ulster County has long been known for its place in New York History as a center for entrepreneurial spirit, industry and commerce which encompasses a wide range of business sectors; and

WHEREAS, This special event is to honor individuals and companies whose effort has contributed significantly to Ulster County; and

WHEREAS, Thirty-six years ago, Dr. Maurice Tischler opened a family dental practice in Woodstock, New York, and in 2007 the tradition expanded to a new modern 10,000 square foot dental facility; sited on nine acres at the gateway to Woodstock, the entire 10,000 square foot facility was designed, built, and materials supplies by Ulster County businesses; and

WHEREAS, Architect Joseph Hurwitz worked with the natural wooded landscape to design and furnish the facility with natural materials and tones; the rustic-style architecture features two waterfalls, 7-foot windows in all twelve dental treatment rooms to frame the natural views, a state-of-the-art surgical suite, and a nationally recognized Teaching Education Center which offers advanced diagnostic, digital radiology, and laser technology; the nature photography throughout the facility is by Dr. Michael Tischler; and

WHEREAS, Five of the nine acres remain untouched, which provides a sense of natural serenity to patients, visitors, and the Tischler professional staff; and

WHEREAS, Dr. Michael Tischler shared that the project was a three-year process with a total cost of \$4 million; this investment is an affirmation of their belief in the vitality of the Ulster County economy and the future; and

WHEREAS, A true asset to society, Tischler Dental's distinguished record merits the recognition and respectful tribute of this Legislative Body; now, therefore, be it


